# Terms and Conditions of Trade

## 1. CONFIRMATION OF ORDERS

Orders should not be taken as being accepted unless an official written confirmation is given, whereupon the Terms and Conditions of Trade shall be deemed to have been accepted and understood. Prices quoted as part of any order shall be the official selling price. Ramm Botanicals reserves the right to change list prices at any time. Minimum order per consignment of 5 trays.

## 2. CANCELLATION CLAUSE

Written notice must be received sixty (60) days prior to shipping date for cutting lines, ninety (90) for Tissue Culture lines. Cancellations outside of these time frames will not be accepted.

## 3. PROVISION FOR PAYMENT

All orders are to be paid for prior to shipping, unless credit or other arrangements have been made. Credit card facilities are available however, please note a 1.2% surcharge is payable on all credit card transactions. Temporary and permanent credit facilities are available to established customers and are subject to acceptance of a formal credit application.

## 4. PRICING, PACKAGING AND HANDLING

All prices quoted are FOB Kangy Angy, NSW unless specifically stated to be otherwise. For all orders freight will be charged at cost plus a packing and handling charge nominated by Ramm Botanicals. All prices of Products include the supply of any tubes or growing trays which are non returnable. Prices are listed exclusive of GST.

## 5. GOODS AND SERVICES TAX

- (a) For the purposes of this Clause unless the context otherwise requires: -
  - (i) "Act means the Act or Acts resulting from the enactment of A New Tax System (Goods and Services Tax) Act 1999 or any act substituted for amending or replacing that act or otherwise providing for any tax called "GST" or a "Goods and Services Tax" and any related Tax Imposition Act (whether imposing tax as a duty of Customs Excise or otherwise) and includes any legislation which is enacted to validate recapture or recoup the tax imposed by any of such Acts;
  - (ii) "GST" means any tax imposed by or through the Act on supply (without regard to any input tax credit);
  - (iii) "Supply" and "Taxable Supply" have the meanings given them in the Act.
- (b) If any "GST" or "Goods and Services Tax" or similar tax is payable, or becomes payable, on any Supply by Ramm Botanicals under an order Ramm Botanicals may recover from the Customer the amount of such GST or similar tax in addition to and at the same time and in the same manner as the Customer is obliged to pay for that Supply.
- (c) Ramm Botanicals will issue the Customer with tax invoices in such a form as would enable the Customer if entitled to claim input tax credits in respect of Taxable Supply.

## 6. TRANSPORT

Ramm Botanicals offers to customers transport options, attracting competitive or discounted rates which are passed on for customers benefit. Any specific requirements for freight and packaging are to be made in writing and to be incorporated as part of any official order. Ramm Botanicals accepts no responsibility for goods damaged in transit.

## 7. DELIVERY SCHEDULE

Notwithstanding any valid cancellation, delivery of any confirmed order for Products must be accepted by the customer within 14 days of notification being given that the Products are ready for shipping. After that period an invoice may be raised against the Products, the terms and conditions of which become enforceable or the order may be cancelled at the discretion of Ramm Botanicals. Any expressed date or time for delivery shall be an estimate only. Ramm Botanicals will use its best endeavors to ship the order as close to the confirmed estimated delivery date as possible.

## 8. QUALITY

Ramm Botanicals will use its best endeavors to ensure that Products are propagated from reliable stock to accepted industry standards of quality and performance. Products will be graded and packed to reach the customer in the best possible condition in accordance with delivery requirements.

## 9. LIABILITY

- (a) Ramm Botanicals gives no warranty expressed or implied as to the description, growth, quality or productiveness Products or of Products further propagated from them. In particular Ramm Botanicals will not be held responsible for the performance of the Product or the resultant crop, its yields, its returns to the customer, or the methods used for crop cultivation. The customer will advise Ramm Botanicals of any genetic or physiological change or disease occurring in any crop although Ramm Botanicals shall not be liable for any losses or damage resulting. Ramm Botanicals shall not under any circumstances be liable for any damage or loss whatsoever (whether direct, indirect, special or consequential, and including damage or loss arising from breach of contract, negligence or otherwise) resulting from any delay in delivery or failure to supply any order for Products or other Products or to carry out any instructions, or from any other cause whatsoever. Moreover, the liability (if any) in respect of the Products actually delivered is limited to the price paid to Ramm Botanicals for the Products or other Products in respect of which any claim may be made.
- (b) Where any Act of Parliament implies, into these Terms and Conditions, any term, and renders void any term that purports to exclude, restrict or modify, or has the effect of excluding, restricting or modifying the implied term, then the implied term shall not be taken to have been excluded, restricted or modified by these Terms and Conditions, but the liability of Ramm Botanicals for breach of any such implied term is limited to:
  - (i) in the case of Products, any one more of the following:
    - the replacement of the Products or the supply of equivalent Products;
    - the repair of the Products;
    - the payment of the cost of replacing the Products or of acquiring equivalent Products; or
    - the payment of the cost of having the Products repaired; or
  - (ii) in the case of services, any one or more of the following:
    - the supplying of the services again; or
    - the payment of the cost of having the services supplied again.

## 10. NON PROPAGATION AGREEMENT

As noted on Ramm Botanicals published price lists, various products are sold under Licence to Ramm Botanicals and/or protected by Plant Breeders Rights. Further propagation from any plants or plant parts derived from them, supplied as part or all of any order is prohibited. Export of those products, except as cut flowers, is also prohibited. Any mutations or sports derived from these products supplied remain

the exclusive property of Ramm Botanicals or its licensor and when observed shall be maintained by the customer and reported to Ramm Botanicals within 14 days. Any request to propagate one of our lines must be submitted in writing.

## 11. TITLE

Title in the Products passes when full payment is received.

## 12. APPLICATION OF PPSA

- (a) In this clause 12, PPSA means the Personal Property Securities Act 2009. If a term used in this clause has a particular meaning in the PPSA, it has the same meaning in this clause.
- (b) This clause 12 applies to the extent that Ramm Botanicals interest in any Goods is a security interest
- (c) The Goods are defined as plastic moulded, thermoformed and assembled products.
- (d) The Purchaser acknowledges and agrees that Ramm Botanicals may apply to register a security interest in the Goods at any time before or after delivery of the Goods. The Purchaser waives its right under s157 of the PPSA to receive notice of any verification of the registration.
- (e) Ramm Botanicals can apply amounts it receives from the Purchase towards amounts owing to it in such order as Ramm Botanicals chooses.
- (f) If the Purchaser defaults in the performance of any obligations owed to Ramm Botanicals under these conditions or any other agreement for Ramm Botanicals to supply goods to the Purchaser, Ramm Botanicals may enforce its security interest in any Goods by exercising all of any of its rights under these conditions or the PPSA. To the maximum extent permitted by law, the Purchaser and Ramm Botanicals agree that the following provisions of the PPSA do not apply to the enforcement by Ramm Botanicals of its security interest in the goods: sections 95, 118, 121(4), 125, 130, 132(3)(d), 132(4), 135, 142, and 143.
- (g) The Purchaser and Ramm Botanicals agree not to disclose information of the kind mentioned in s275(1) of the PPSA, except in circumstances required by sections 275(7)(b) – (e) of the PPSA.
- (h) The Purchaser must promptly do anything required by Ramm Botanicals to ensure that Ramm Botanicals's security interest is a perfected security interest and has priority over all other security interests in the Goods.
- (i) Nothing in this clause 12 is limited by any other provision of these Conditions or any other agreement between the parties.

## 13. INTEREST ON OVERDUE ACCOUNTS AND STOP SUPPLY

If any payment is not made in full on the due date the Customer will be in default and, without limiting any other rights of Ramm Botanicals (including to demand immediate payment), Ramm Botanicals may:

- (a) Charge the Customer interest on the amount outstanding as compensation for the loss of its funds calculated on accounts in 60 days until payment is made in full effective from 1 March 2016. The rate of interest applicable is 3% per month; and
- (b) Stop supply of the goods to the Customer may occur until all outstanding amounts have been paid in full.

## 14. VARIATIONS

No variation of the above written conditions shall be of any effect unless it has been subsequently agreed upon in writing. The placing of any order is deemed to provide an understanding and acceptance of Ramm Botanicals terms and conditions of trade, which are governed by the laws of New South Wales.



# Plant Finishing and Trademark Agreement

## THIS AGREEMENT IS MADE ON BEHALF OF:

**RAMM BOTANICALS PTY LTD as trustee for The Ramm Botanicals Trust of 255 Pacific Highway, Kangy Angy NSW 2258 Australia, hereinafter referred to as 'RAMM' of the one part.**

## RECITALS

(a) RAMM is the owner of or acts with the authority of the owner to authorise the sale of the plant variety or varieties described in the Ramm Botanicals Catalogue (RBC) hereof ("the Varieties" but if only one, all references to "Varieties" herein should be read as "Variety").

(b) The LICENSEE wishes RAMM to grant it the right to grow and sell the Varieties listed in the RBC.

(c) RAMM is the owner of or acts with the authority of the owner of the variety or trade marks in the RBC. ("Trade Marks" but if only one, all references to "Trade Marks" herein should be read as "Trade Mark").

## IT IS AGREED AS FOLLOWS:

### INTERPRETATION

- (i) Except for the purpose of identification, headings and underlining have been inserted in this Agreement for the purpose of guidance only and shall not be a part of this Agreement.
- (ii) This Agreement shall be binding upon the heirs, executors, administrators and assigns.

## LICENCE

1. RAMM grants to the LICENSEE a non-exclusive licence and authority to finish, market and sell the Varieties. The term 'finish' or 'finishing' refers to the growing-on of the Varieties and does not grant or infer propagation rights.
2. RAMM grants to the LICENSEE a non-exclusive licence to use the Trade Marks in each case only upon or in relation to the Varieties indicated against the relevant Trade Mark in the RBC.
3. The LICENSEE will sell the Varieties only with reference to the relevant Trade Marks.
4. The LICENSEE will use the Trade Marks only in relation to plants finished from cuttings or plant material supplied to it by RAMM or its nominated propagator.
5. The LICENSEE will apply the Trade Marks to the Plants only by affixing labels or such other device as directed by RAMM from time to time bearing the Trade Marks to the containers for the Plants, such labels or other device to be supplied by or on behalf of RAMM or from a Ramm-approved source. If such labels are produced by the LICENSEE, such designs are to be authorised in writing by RAMM.
6. The LICENSEE undertakes to exercise the Licence by the finishing of the Varieties.

## OBLIGATIONS OF RAMM

7. RAMM warrants that to the best of its knowledge and belief it has the right to grant the Licence and it has not done or omitted to do any act, matter, or thing whereby the Licence may be invalidated or prejudicially affected.
8. RAMM does not in any way make any representation or give any warranty as to the validity of any registration of the Varieties under relevant laws in the Territory or as to any commercial benefit of the Licence to the LICENSEE.

## OBLIGATIONS OF LICENSEE

9. The LICENSEE shall, if it becomes aware of any infringement or threatened infringement of any registration of the Varieties, immediately notify RAMM in any legal proceedings relating thereto. RAMM reserves to itself the right, in its absolute discretion, to take any steps or actions to restrain any infringement and to recover all sums of money awarded and materials delivered up as a result of such proceedings.
10. The LICENSEE acknowledges the proprietorship of RAMM or exclusive marketing rights of RAMM and shall render all reasonable assistance to RAMM in the maintenance of those rights and shall not (to the extent permissible by law) contest the validity of any registration of them.
11. The LICENSEE shall not use the Trade Marks or any other trade marks substantially identical with or deceptively similar thereto other than pursuant to this agreement.
12. The LICENSEE shall not use the Trade Marks in any manner likely to deceive or cause confusion or to jeopardise the exclusiveness or distinctiveness of the Trade Marks or RAMM's proprietorship of the Trade Marks.
13. The LICENSEE shall, if it becomes aware of any infringement or threatened infringement of the Trade Marks, immediately notify RAMM giving full particulars and shall reasonably assist, as requested by RAMM, in any legal proceedings relating thereto. RAMM reserves to itself the right, in its absolute discretion, to take any steps or actions to restrain any infringement of or to enforce the Trade Marks and to recover all sums of money awarded and materials delivered up as a result of such proceedings.
14. The LICENSEE shall report to RAMM immediately any sport, bud variation or mutation found in the Varieties and agrees to maintain such material at the direction of RAMM. The LICENSEE acknowledges that any plant breeder's rights in such sports or mutations will be owned either by RAMM, its nominee or the breeder of the Variety. All such mutations shall be maintained by the LICENSEE until instructions for handling are received from RAMM.
15. The LICENSEE shall not reproduce the Varieties, or sell the Varieties as unrooted cuttings, struck cuttings, plug stock or tubestock or remove flowers for the purpose of cut flower sales.
16. The LICENSEE shall sell the Varieties only with an appropriate label or other device supplied by or on behalf of RAMM, or if such labels are produced by the LICENSEE, such designs are to be authorised by RAMM.

## ADVERTISING AND PROMOTION

17. Subject to Clause 18, the LICENSEE shall, during the Term, use all reasonable endeavours to advertise and promote the sale and distribution of the Varieties and, at its own expense, shall undertake advertising and promotion of the Varieties.
18. The LICENSEE shall not advertise or promote the Varieties without submitting to RAMM full details of that proposed advertising and promotion and without the prior written consent of RAMM as to the form and content of the advertisement or promotion concerned (that consent not to be unreasonably withheld).

## REPORTS AND CONDITIONS

19. The LICENSEE shall keep in such form as may be reasonably required by RAMM from time to time (hereinafter referred to as "the Records"):
  - (a) Accurate records of the Varieties sold or otherwise disposed of by or for the LICENSEE

## QUALITY CONTROL AND INSPECTION

20. The LICENSEE agrees that it will not carry over old stock of the Varieties from one season to the next without the authority of RAMM.
21. The LICENSEE shall otherwise exercise the Licence only in accordance with standards approved and directions given by RAMM from time to time.
22. The LICENSEE shall use its best endeavours to ensure that the Varieties are protected from infection and infestation of any kind. Where plant health issues arise, which appear to result from factors outside the control of the LICENSEE, the LICENSEE must advise RAMM as soon as practicably possible.
23. The LICENSEE shall strictly comply with all relevant consumer product health and safety laws, standards and regulations relating to the Varieties from time to time.
24. The LICENSEE acknowledges RAMM's right, by itself and by its authorised representatives, upon reasonable notice to the LICENSEE and at all reasonable times during the Term to inspect the LICENSEE's exercise of the Licence and in particular to inspect stock areas, finishing areas and production and sales records of the LICENSEE for the Varieties.



# Plant Finishing and Trademark Agreement

## TERMINATION

25. This agreement shall automatically terminate upon any of the following events:
  - (a) the LICENSEE ceasing to carry on its day-to-day business activities, going into liquidation (voluntarily or otherwise) or making any arrangement with its creditors, or being admitted to the benefits of any other procedure for the settlement or compromise of its debts; or
  - (b) the LICENSEE disposing of or otherwise dealing with or encumbering substantially all of its assets other than pursuant to its day-to-day business activities.
26. Termination of this agreement shall be without prejudice to any other rights which may have accrued to the terminating party.
27. Upon termination of this agreement for any reason the LICENSEE shall:
  - (a) Subject to clause 28 cease all exercise of the Licence;
  - (b) Cease all use (if any) of any corporate style or trading name containing or referring the Trade Marks or any other trade marks substantially identical with or deceptively similar thereto;
  - (c) Within 14 days pay to RAMM all monies (if any) payable to RAMM whether under this agreement or otherwise and whether then due or owing or otherwise payable at some future date.
28. The LICENSEE shall have the right to sell the Remaining Inventory on hand at the time of termination subject to payment of the Royalty and the furnishing of reports and statements as hereinbefore provided, PROVIDED HOWEVER that the right to sell the Varieties in the Territory after termination shall be limited to a period of six months from the date of such termination. RAMM may, in its absolute discretion, offer to purchase the Remaining Inventory from the LICENSEE at a price to be agreed upon.

## PRODUCT LIABILITY

29. The LICENSEE shall not, by itself, its servants, agents and distributors, hold out or permit the holding out of RAMM as the producer of the plants sold by the LICENSEE pursuant to this agreement and shall indemnify RAMM and keep RAMM indemnified against all claims and liabilities whatsoever arising directly or indirectly from the production, distribution, sale, offering for sale and use of the Varieties or anything connected with or consequent upon such matters.

## GENERAL

30. This agreement shall not be construed as creating a joint venture, partnership or agency between RAMM and the LICENSEE. The Licence granted hereunder is personal and the LICENSEE shall not be entitled to assign, sub-licence, mortgage or otherwise encumber its rights, duties or obligations hereunder without the prior written consent of RAMM which consent shall not be unreasonably withheld. RAMM may assign its rights hereunder to any third party upon one calendar month's notice to the LICENSEE PROVIDED THAT RAMM simultaneously assign its rights in the Varieties in the Territory to that third party.
31. This agreement supersedes and shall be in substitution for and extinguish all previous oral or written agreements or understandings between the parties hereto concerning the Licence and the subject matter to this agreement.
32. All rights granted to RAMM hereunder are cumulative. The non-exercise or waiver of any right of RAMM shall not adversely affect RAMM's subsequent exercise of the same right or any other right for the same or any subsequent breach or threatened breach.
33. This agreement shall be governed by and construed in accordance with the laws of New South Wales and each of the parties hereby submits to the non-exclusive jurisdiction of the Courts of that State.
34. Any stamp duty or other government tax or duty imposed on this agreement together with the legal costs incurred by RAMM in connection with the preparation of this agreement shall be the sole responsibility of and shall be paid solely by or on account of the LICENSEE.
35. Any notice required to be given hereunder shall be deemed to have been given five days after the same shall have been sent by email to the address of the other party
